THE CLINIC USES AN EFFICIENT AND EFFECTIVE TEAM APPROACH TO PROVIDE FREE PRIMARY HEALTH CARE FOR THESE VULNERABLE MEMBERS OF OUR COMMUNITY, INCLUDING PHYSICAL EXAMS, MANAGEMENT OF CHRONIC ILLNESS, DIAGNOSIS AND TREATMENT OF ACUTE ILLNESS, NON-SURGICAL ORTHOPEDIC AND CARDIOLOGY CARE, MENTAL HEALTH CARE, HEALTH EDUCATION, SPECIALTY REFERRAL AND PRESCRIPTION ASSISTANCE. THESE SERVICES ARE ENHANCED BY THE AVAILABILITY OF PRAYER AND SPIRITUAL SUPPORT, AS OUR PATIENTS MAY DESIRE. THE CLINIC'S PAID STAFF INCLUDES FOUR PART-TIME POSITIONS (1.8 FTES). ALL MEDICAL SERVICES ARE PROVIDED BY VOLUNTEERS, INCLUDING OVER 30 CLINICIANS (GENERAL PRACTICE PHYSICIANS, SPECIALTY PHYSICIANS, A PHYSICIANS ASSISTANT, NURSE PRACTITIONERS, REGISTERED NURSES AND A PHARMACIST). MORE THAN 30 NONCLINICAL VOLUNTEERS STAFF THE FRONT OFFICE, PRESCRIPTION ASSISTANCE PROGRAM, SPIRITUAL SUPPORT SERVICE AND ADMINISTRATIVE SUPPORT SERVICES. DURING 2017, 457 UNDUPLICATED PATIENTS MADE 1,529 VISITS TO THE CLINIC'S PHYSICIANS AND NURSE PRACTITIONERS FOR MEDICAL CARE, AND 1,589 VISITS TO THE CLINIC'S REGISTERED NURSES FOR MEDICATION ASSISTANCE, EDUCATION AND HEALTH CARE SUPPORT.
