PROGRAM INITIATIVES ARE TO ASSURE PREVENTATIVE HEALTH SERVICES TO THE UNINSURED IN THE COMMUNITY AND TO COORDINATE OUTREACH SERVICES WITH LOCAL HOSPITALS, PHYSICIANS AND SOCIAL SERVICES.
